Our work is more important than

Although the Democratic Party Platform contains positive language on U.S. leader-



ship at the UN, no speaker at the party's national convention mentioned the world body, aside from the promise to rejoin the Paris Climate Agreement (that's good, but only a first step).

Day One of the Republican National Convention featured Nikki Haley denouncing the UN as a place "where dictators, murderers and thieves denounce America and then put their hands out and demand that we pay their bills."

The Democrats' near silence and the Republicans' anti-UN rhetoric ignore the reality that most Americans believe the UN is a useful organization. The Better World Campaign's most recent public opinion poll shows that 88% of America voters believe that it's important for the U.S. to maintain an active role within the United Nations.

With the U.S. elections on the horizon, it is important for every citizen to make a plan to vote. It is also important to tell current officeholders and candidates that there is a constituency for constructive U.S. leadership in the United Nations.

The United States was instrumental in creating the WHO in 1948. The WHO has eradicated smallpox worldwide, nearly eradicated polio and expanded basic health care services worldwide in low income countries. When the world is experiencing a global pandemic, it seems unreasonable to withdraw from the international organization dealing with health issues and coordinating the international response.

All United Nations organizations operate under the guidance of its 193 member states, and it is not always easy to manage everyone's interest. Futrhermore, all the UN agencies are set up to find the truth and not simply the views of the

major funders.

The WHO website provides perhaps the best information about the coronavirus. If anyone wants to find the best information, it is best to look for an independent source, and the World Health Organization provides it to. See: www.who.int

On this website you can see the latest news and advice for both the public and health-care workers, technical guidance, updates and the latest research and development. You can also watch the WHO press conferences for the latest updates on the global response to #COVID19, Monday, Wednesday, Friday at 15 GMT or 10:00 CDT.

The withdrawal of the United States from the WHO would cut its funding significantly. As a result, what the WHO can accomplish will inevitably be reduced as well.

The UN Turns 75

Representatives of the 193 UN member states will mark the 75th anniversary of the world organization by holding a one-day high-level meeting of the UN General Assembly on Monday, September 21. The theme will be "The Future We Want, the UN We Need: Reaffirming our Collective Commitment to Multilateralism."

A high point of the session will be the formal adoption of a Declaration on the Commemoration of the Seventy-fifth Anniversary of the United Nations, negotiated earlier this year. The declaration states that the UN "has helped mitigate dozens of conflicts, saved hundreds of thousands of lives through humanitarian action and provided millions of children with the education that every child deserves. It has worked to promote and protect human rights and fundamental freedoms for all, including the equal rights of men and women."

Yet, the declaration also notes that there have been "moments of disappointment" and the world is plagued with "growing inequality, poverty, hunger, armed conflicts, terrorism, insecurity, climate change, and pandemics."

girls at the center, build trust, and improve digital cooperation. Finally, the declaration pledges to "upgrade the United Nations," to make it "more agile, effective, and accountable."

The text states that the declaration is a response to the Global Conversation launched by the Secretary-General to mark the 75th anniversary. Here in the United States, UNA-USA hosted community level consultations in all 50 states, engaging nearly 2,000 people. Participants addressed three questions: "Are we on track to secure a better world?" "What kind of future do we want to create?" and "What action is needed for a brighter future?"

In Iowa, consultations were held with students at Drake University, and Iowans participated in a national virtual consultation in June (a planned in-person consultation in Johnson County was cancelled due to the pandemic). This summer, UNA-USA issued a report summarizing the consultations. Participants expressed a widespread sense of concern: 77% expect a worse world in 2045 based on current trends. Almost half reported that education,

reduced inequalities, climate action, and "peace, justice, and strong institutions" are essential. The report

calls for increased activism and advocacy at all levels.


