# UN Rallies Cooperation for Global Health and Racial Justice

The United Nations is addressing the COVID-19 pandemic and racism, even as the United States undermines these efforts.

Over the past three months, UN Secretary General Antonio Guterres has issued a series of statements and reports to put the pandemic in a broader context by showing the impact of COVID-19 on migration, food security, mental health, and vulnerable populations, including women and children. An April 2020 report called on member nations to view the pandemic through a human rights lens and to ensure that responses to their public health policies are inclusive, equitable and universal so that no one is left behind.

In June, after the death of George Floyd, senior UN officials who are African or of African descent issued a statement supporting the Secretary-General's initiatives for racial justice but urging that more must be done. Deputy Secretary General Amina Mohammed called this work a "sacred duty."

UN deliberative bodies have also

been seized with these issues. In May, the U.S. blocked a Security Council resolution – negotiated over several weeks – calling for a worldwide ceasefire during the pandemic. The U.S. objected to an indirect reference to the World Health Organization (WHO) in the text. Earlier the U.S. criticized the WHO for deferring to China and for a slow response to the emerging pandemic and later President Trump announced that the U.S. would terminate its relationship with the WHO.

In June, the UN Human Rights
Council – from which the U.S has
withdrawn – unanimously adopted
a resolution calling on the UN High
Commissioner for Human Rights to
prepare a report on "systemic
racism and violations of human
rights law against Africans and
people of African descent by law
enforcement agencies."

Meanwhile, in the field, UN agencies are working to mitigate the impact of COVID-19. The WHO is training health personnel around the world in best practices for mitigating the pandemic and

sharing information on the development of a vaccine. UNICEF is delivering medical supplies and working to devise ways to help children continue to learn in the face of pandemic-related school closures. The UNHCR is providing health, water, and sanitation services to protect the 71 million refugees and forcibly displaced persons worldwide.

The Trump administration's proposed FY2021 budget calls for a 34% cut in funds for global health and a 100% cut in the U.S. contribution to UNICEF. In addition to withdrawing from the UN Human Rights Council and the WHO, noted above, the U.S. has also withdrawn from two other UN agreements, the Paris Climate Agreement and the Global Compact on Migration.

As the UN marks its 75<sup>th</sup> year, the U.S. – as one of the original 51 members, a major financial contributor, a permanent member of the Security Council, and host to UN Headquarters – ought to join with others to make the UN even more effective.

Our voices calling for constructive U.S. leadership in the UN are more important than ever. Thanks for all you do.



## Night of 1000 Dinner Highlights

The 20<sup>th</sup> Annual Night of 1000 Dinners, March 11, marked International Women's Day by honoring three local organizations advancing the UN Sustainable Development Goals (SDGs). The event raised funds for implementation of the SDGs by UN agencies and Johnson County groups.

The event, supported by 23 local business and non-profit organizations, featured an international buffet. Former mayors Naomi Novick and Jim Throgmorton, as well as current mayor Bruce Teague, were among the 80 attendees.

The Johnson County UNA Chapter and the University of Iowa Campus Chapter honored three

organizations for their work to implement the SDGs: the League of Women Voters of Johnson County, the Combined Efforts Theater, and the Iowa City Student Climate Strikers.

Night of 1000 Dinners raised \$3,500, which was donated to the United Nations Children's Fund (UNICEF), the UN High Commissioner for Refugees, the COVID-19 Pandemic Response Fund, the Center for Worker Justice, the Refugee and Immigrant Association, and the Iowa United Nations Association.
